State Mental Health Cuts: The Continuing Crisis

In November 2011 the National Alliance on Mental Illness (NAMI) released *State Mental Health Cuts: The Continuing Crisis* as a follow up to a report on the same subject conducted earlier in the year. The authors found that states have cut more than \$1.6 billion in general funds from their state mental health agency budgets for mental health services since FY2009, a period during which demand for such services increased significantly. These cuts led to significant reductions in both hospital and community services for vulnerable individuals with serious mental illnesses.

Today, with demand for public mental health services extremely high, especially at a time of severe economic distress, the crisis in mental health care continues.



The impacts are felt throughout society as people go without the treatment they need.

Increasingly, emergency rooms, homeless shelters and jails are struggling with the effects of people falling through the cracks due to lack of needed mental health services and supports.

In contrast, some states increased their state general fund appropriations for mental health in FY2012. However, these increases do not mitigate the damage that has been done by cuts to the infrastructure of services for people living with the Crisis Line 1-877-695-NEED (6333)

Modest increases in state general fund mental health spending fail to compensate for the loss in federal Medicaid revenues that hit states due to reductions in federal Medicaid rates implemented at the end of June 2011.

Ohio, by example, has shifted state general fund mental health dollars to Medicaid recipients, leaving many non-Medicaid recipients with a serious mental illness without services. This will have a ripple effect on many who do not qualify for Medicaid but cannot afford services on their own.

NAMI offers a series of policy recommendations including: 1. Protect and strengthen mental health services and restore spending cuts

2. Improve data collection and outcomes measurement for mental health services

3. Preserve access to acute care and long-term care services

County and MHRS Complete Land Swap Deal

The Warren County Commissioners and MHRS have swapped ownership of properties located at 210 W. Main Street, Lebanon, (Corwin House) and 212 Cook Road, Lebanon, (where the MHRS administrative offices currently stand).

"It's a win-win for both parties," said Brent Lawyer, executive director of Mental Health and Recovery Services. Lawyer said that the mental health board had owned its administrative offices at the intersection of Cook Road and Justice Drive, but not the land where it sat until now. The county said Corwin House would be used as an auxiliary office for the county engineer's office, which is outgrowing its current location on Markey Road.
